

SUPPLY CHAIN SECURITY AUDIT PROGRAM CUSTOMS-TRADE PARTNERSHIP AGAINST TERRORISM (C-TPAT)

In 2001, the US Government Customs and Border Protection (CBP) launched the C-TPAT program to address security risks in the U.S. market. C-TPAT is a voluntary government-business initiative to build cooperative relationships that strengthen and improve overall international supply chain and U.S. border security. To date, over 10,000 companies have joined C-TPAT.

C-TPAT member companies benefit from this program by having fewer inspections on their shipments coming into the United States. On average, members are three and a half times less likely to be inspected and seven times less likely to receive an intense examination of their cargo. Fewer customs delays mean better profits on seasonal items for retailers and faster time to market.
