- Labelling elements that are required on national basis

### NUTRITIONAL LABELLING

At least 74 countries and trading blocs have some form of nutritional labelling regulations, or are in the process of enacting them. However, there is little consistency between countries, except perhaps in Europe. To achieve full compliance, labels need to be reviewed by experts who understand the specific labelling regulations of the country to which the product will be imported. Our experts are competent and knowledgeable of the many and varied country specific requirements.

# **HEALTH/NUTRIENT CONTENT CLAIMS**

Heavily regulated, food and food products bearing health and/or nutrient content claims must be both proven and permitted. Regulators closely control claims, including the European Food Safety Agency (EFSA) in the EU and the US Food and Drug Administration (FDA). Our food health/nutrient claim testing services make sure that all ingredients are listed and claims verified.

### **GMO LABELLING**

A particularly complex area, labelling of genetically modified (GMO)/genetically engineered (GE) products is required by some 64 countries, with each country's requirements being different. Europe has well established requirements while the USA has recently introduced a federal law requiring the labelling of food and food products containing GMO/GE.
