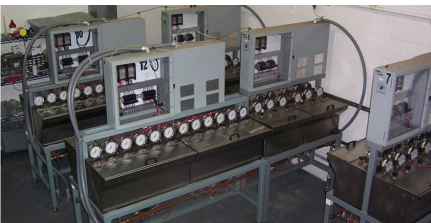

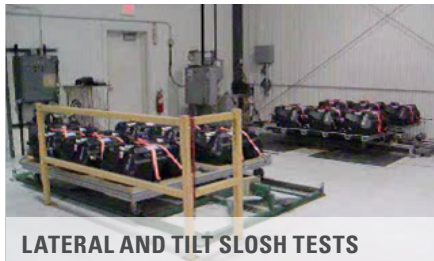

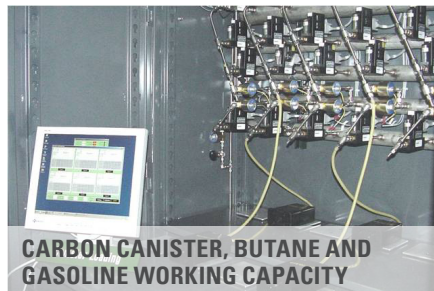
LATERAL AND TILT SLOOP TESTS



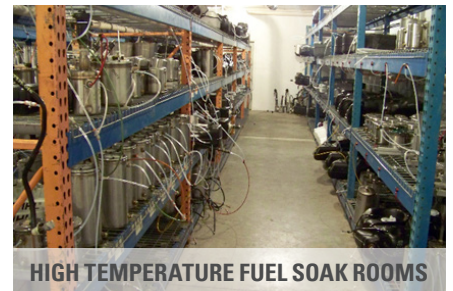

CARBON CANISTER, BUTANE AND GASOLINE WORKING CAPACITY



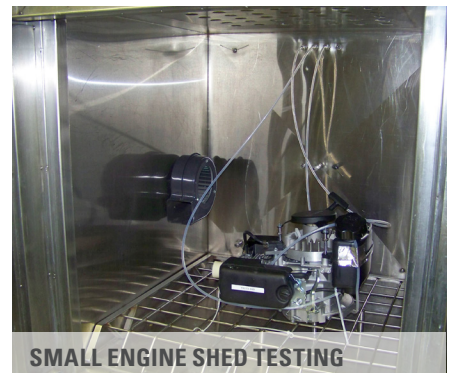
