DEMONSTRATE PRODUCT COMPLIANCE

The CE marking demonstrates a product's compliance with EU legislation for the European Economic Area (EEA), as well as Turkey, and enables the free movement of products within the European market.

Products must bear the CE marking if categories subject to specific European directives (EC) that provide for the CE marking are required to be CE marked.

By placing the CE marking on a product, the manufacturer or importer assume on his sole responsibility, the conformity with all of the legal requirements to achieve the CE marking.

TECHNICAL CONSTRUCTION FILE

A product's technical construction file identifies the item, lists relevant regulations and contains all the evidence that its design is compliant. It is important that this file describes assessment activities and the outcomes. In addition, the file should comprise details including: the name of the company that designed the product; the name and function of the file's owner; product name; type designation and descriptionat





DECLARATION OF CONFORMATY

CE Marking on a product is a manufacturer's declaration that the product complies with the essential requirements of the relevant European health, safety and environmental protection legislation, in practice by many of the so-called Product Directives.

Along with more directives' becoming effective, more and more products are required to bear the CE Marking for gaining access to the EFTA & European Union market.
